AUTHOR GUIDELINES FOR SUBMISSION OF ABSTRACTS - ICNATLIB 2026

Submission Specifications and Instructions for Preparing Abstracts

Please follow the guidelines below when preparing your abstract for the conference:

- The abstract must be written in **English**. The committee will only accept submissions in this language. However, if your abstract is accepted, you may submit the extended abstract in **Sinhala, English, or Tamil**.
- The submission must be **original** and not previously presented or published elsewhere. Abstracts that are identical or substantially similar to work already published or under review for another conference or publication will not be considered.
- If your abstract is accepted by the conference committee, at least one author must register for the conference and present the paper.
- Guidelines for preparing abstracts are provided in Annexure I. Please note that abstracts not prepared according to the given guidelines or submitted after the deadline will not be considered for review.
- The Editorial Committee reserves the right to make modifications to the abstract to enhance its clarity and quality.

Abstract - The language of the abstract is English and it should be written in Times New Roman, with a 12-size font and the document should be 1.15 lines spaced. The word limit should not exceed the number of words 300. The fonts, sizes and styles for the title, names of authors, and affiliations, should be as shown in the header of the paper. The name of the corresponding author should be underlined. Abstracts should be submitted in Microsoft Word format. The abstract should state the Background and purpose of the study, objectives, methodology, main findings and their principal conclusions. Do not include section headings in the abstract. Citations, References, Figures and Tables should not be included in the abstract.

Keywords: Please add a minimum of 4-5 words separated by commas.

Introduction : The introduction of your extended abstract should state the nature of the research gaps you are addressing and why you are studying it. It should provide background information about the work and its significance while highlighting other relevant literature and specifying how it relates to or differs from your work. You should also discuss the scope and limitations of your study in the introduction.

Objectives : Objectives of the study should be clearly defined

Methodology: Provide a full description of your general research design, as well as the specific methods and procedures used in your research study. Describe your theoretical approach or type of analysis, and discuss the types of sources (primary or secondary texts, interviews, surveys, personal notes, etc.) and analysis tools (including statistical method/s) used.

Results: Describe the results in a logical framework providing diagrams, charts, and illustrations as appropriate for your discipline.

Discussion: The purpose of the discussion is to interpret and describe the significance of your findings in light of what was already known about the research problem being investigated, and to explain any new understanding or fresh insights about the problem after you've taken the findings into consideration.

Conclusion: The conclusion is intended to help the reader understand why your research should matter to them and provide a synthesis of arguments presented in the paper to show how these converge to address the research problem and the overall objectives of your study. Also state your conclusions in clear, simple language.

References: References should be cited within your extended abstract using **APA 7th edition** (American Psychological Association). Examples of reference formats are given

here. For additional information on formatting references, refer to the 7th edition of the publication manual of the American Psychological Association.

Extended Abstract Length: Extended abstracts should be at least three pages, but not more than five pages in length including the references. Word limit is 1,300 – 1,500 words.

Tables & Figures: Tables & figures must be created using the Microsoft Word or Word Perfect table functions and included as part of the text immediately after the first point of reference. DO NOT place them at the end of your extended abstract. For improved readability, keep your tables as simple as possible.

All the tables, images and figures should be centered. Figures and images should be numbered and figure legends should be placed under the figure or image; as for the tables, they should also be numbered and the table header should be placed at the top. If the data were extracted from other sources please denote the source courtesy immediately below the table.

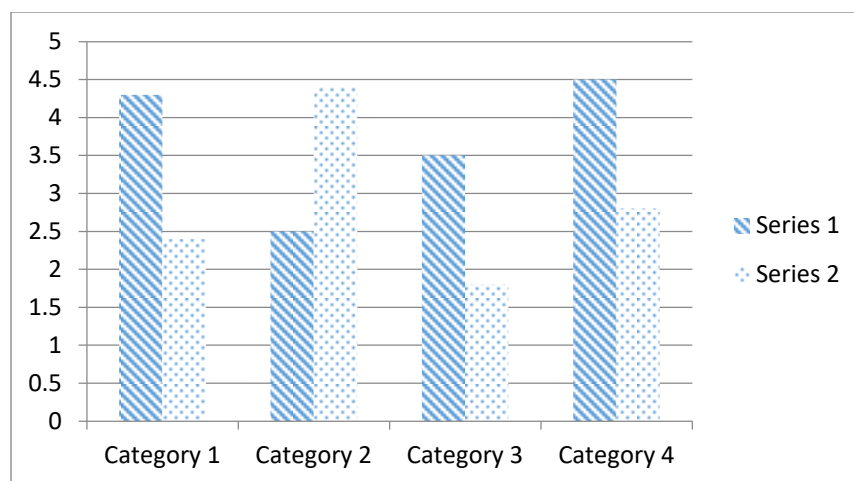


Figure 2 : Preferences of students on different modes of obtaining reading materials
